



FIELD TRIP AUTHORIZATION FORM PARK Permission 2013/2014

From time to time, we take the students to the City of Ottawa Park next door to our school. We visit the park for curriculum based activities as well as for play. These visits are not pre-scheduled, but rather spontaneously planned by classroom educators, based on the weather, and the day's activities.

Be assured that we undertake the same safety precautions at the park as we do for our yard play. This includes completing a yard-check for safety prior to letting the children play. Our yard checks are kept on file and are reviewed by our licensing inspector. Our educator to student ratios remain the same, and the children travel safely from the side door through the park gate, keeping out of traffic areas.

You will be notified that your child has participated in a park visit by way of their communication book, or by way of the classroom whiteboard.

We ask that you complete one permission form only for the school year. Please feel free to discuss this further with Alsace Abboud, should you have any concerns.
